

# ADMINISTRATIVE GUIDE FOR THE CONDUCT OF THE $12^{TH}$ ANNUAL GENERAL MEETING ("AGM")

## 1. Safety measures to minimise risks of COVID-19 infection

For the conduct of the 12<sup>th</sup> AGM, the Company wishes to advise the shareholders that the Company will be taking precautionary measures in line with the Standard Operating Procedures ("SOP") and guidelines issued by Majlis Keselamatan Negara ("MKN") and Ministry of Health Malaysia ("MOH") as well as any revisions that may be made from time to time by MKN, MOH and/or the relevant authorities to curb the spread of COVID-19.

If you are unwell with sore throat, flu, fever, cough, aches and pains, nasal congestion, diarrhoea or shortness of breath, you are required to comply with the directives issued by Ministry of Health to self-quarantine or seek medical advice and will not be allowed to attend the 12<sup>th</sup> AGM. You are hereby strongly advised and encouraged to submit your Proxy Form prior to the 12<sup>th</sup> AGM to appoint a proxy or the Chairman of the meeting to attend and vote on your behalf.

All attendees are advised to sanitise their hands and wear face mask before entering. Wearing a face mask throughout the 12<sup>th</sup> AGM proceedings is highly encouraged.

### 2. Pre-registration to attend the AGM

Pursuant to the revised Guidance and Frequently Asked Questions ("FAQs") on the Conduct of General Meetings for Listed Issuers issued by the Securities Commission Malaysia on 8 March 2022 and any revisions that may be made from time to time by MKN, MOH and/or the relevant authorities, shareholders are required to register ahead of the 12<sup>th</sup> AGM to allow the Company to make the necessary arrangements in relation to the meeting i.e. infrastructure, logistics and meeting venue(s) to accommodate the meeting participants.

Please read and follow the **procedures to pre-register your physical attendance at the 12<sup>th</sup> AGM** via the TIIH Online website at https://tiih.online:

- Login to TIIH Online website with your user name (i.e. e-mail address) and password under the "e-Services". If you have not registered as a user of TIIH Online, please refer to the tutorial guide posted on the homepage for assistance to sign up.
- Select the corporate event: "(REGISTRATION) Boilermech Holdings Berhad 12<sup>th</sup> AGM".
- Read and agree to the Terms & Conditions and confirm the Declaration.
- Select "Register for Physical Attendance at Meeting Venue".
- · Review your registration and proceed to register.
- System will send an e-mail to notify that your registration for Physical Attendance at Meeting Venue is received and will be verified.
- After verification of your registration against the General Meeting Record of Depositors, the system will send you an e-mail after 24 August 2022 to approve or reject your registration to attend physically at the Meeting Venue.

# 3. Eligibility to attend based on the Record of Depositors

Only a shareholder whose name appears on the Record of Depositor as at **19 August 2022** shall be entitled to attend or appoint proxy(ies) to attend and/or vote on his/her behalf.

# 4. Registration on the day of the 12<sup>th</sup> AGM

- a. Registration will commence at 9.00 a.m.
- b. Please present your original National Registration Identity Card (NRIC) or Passport to the registration staff for verification.
- c. A voting slip and an identification wristband will be given to you thereafter. No one will be allowed to enter the meeting room without an identification wristband.
- d. Registration must be done in person. No person is allowed to register on behalf of another.
- e. The registration counter will handle verification of identity, registration and revocation of proxy/proxies.

## 5. Door gifts

There will be no distribution of door gifts at this AGM.

#### 6. Refreshments

Refreshments will be served at this AGM.

# 7. Appointment of Proxy

A shareholder who is unable to attend the 12<sup>th</sup> AGM on 26 August 2022 may appoint proxy and indicate the voting instructions in the proxy form. User with TIIH Online	<ul> <li>Access TIIH Online at <a href="https://tiih.online.">https://tiih.online.</a></li> <li>Under e-Services, the authorised or nominated representative of the corporation or institutional shareholder selects the "Sign Up" button and followed by "Create Account by Representative of Corporate Holder".</li> <li>Complete the registration form and upload the required documents.</li> <li>Registration will be verified, and you will be notified by email within one (1) to two (2) working days.</li> <li>Proceed to activate your account with the temporary password given in the email and re-set your own password.</li> </ul>
